

# **RULES & REGULATIONS OF BCN SPORTS FILM FESTIVAL 2019**

---

## **INTRODUCTION**

The Barcelona Olympic Foundation, with the support of the Barcelona City Council, organizes the BCN Sports Film 2019 – 10th BARCELONA INTERNATIONAL FICTS FESTIVAL. The event is sponsored by FICTS – Fédération Internationale de Cinéma et Télévision Sportifs and forms part of the WORLD FICTS CHALLENGE 2019.

The BCN Sports Film 2019 will be held in Barcelona from 3rd to 9th June 2019. This tenth edition of the Festival will have a competitive nature.

These Rules & Regulations have been approved by the BCN Sports Film 2019 Organising Committee. Your taking part in BCN Sports Film 2019 implies the total acceptance of these regulations.

## **AIMS**

One of the principal objectives of BCN Sports-Film 2019 is to bring the general public into contact with sports-orientated audiovisual content and the values that they represent. Whilst offering the media, film directors, producers and specialised distributors a meeting place in which they can exchange views and information.

## **CONTENT**

The BCN Sports Film 2019 is open to all those productions in which the principal subject matter is that of sport in all its forms and disciplines.

Genres included: animated films, documentaries and fiction, from shorts to feature length films, no time limit.

## **GENERAL RULES**

BCN Sports Film 2019 is open to both professional and independent productions.

BCN Sports Film 2019 will admit all films premiered from January 2017.

Each producer may present as many films as he wishes as long as they comply with all other regulations. BCN Sports Film 2019 may programme non-competing films of general interest whatever their date of production.

## **JURY**

The BCN Sports Film 2019 Organising Committee will appoint the official Festival jury.

The BCN Sports Film 2019 jury will comprise popular personalities drawn from the worlds of sport, cinema, audiovisual production and culture.

All their decisions and verdicts are final and without recourse.

## **PRIZES**

Selected Films will be competing for:

- The City of Barcelona Amphora for the best film
- Award for the best Catalan production
- Award for the best adventure sports film – Álvaro Bultó
- Award for the best fiction film
- Award for the best documentary
- Award for the best animated film

The BCN Sports Film 2019 official jury may make as many special awards as they deem fit.

Festival sponsors may endow other awards with prizes in cash or kind. The City of Barcelona Amphora for the best film and the Jury's Special Award are endowed with a prize of € 1000. All other awards are endowed with a prize of € 500.

## **INSCRIPTIONS**

Inscriptions will be accepted from 15th November 2018 till 15th February 2019, both inclusive.

## **WORKS SELECTED**

The Organizing Committee will notify participants by email and before 31st March 2019 should film have been selected for the BCN Sports Film 2019 official competition.

Other promotional material may be requested by the organisation.

The organisation will provide the subtitles in Catalan or Spanish for exclusive use during the event.

## **PROJECTION**

Those films selected to participate will be projected as scheduled in the Festival Programme.

Films selected to compete will form part of the documentary and video-graphical material of the Library of the Barcelona Olympic Foundation where public exhibition in the Joan Antoni Samaranch Olympic Museum, (headquarters of the Barcelona Olympic Foundation) will be strictly limited to educational activities and as a means to increase public awareness of the Festival.

Winning films may be shown free of charge for the promotion of BCN Sports Film Festival at any of the other Olympic Museums in the world.

Winning films will be eligible to participate in the final international stages of the WORLD FICTS CHALLENGE. The winners explicitly authorise the BCN Sports Film 2019 Organising Committee to provide their contact information to the Organising Committees of the other WORLD FICTS CHALLENGE Festivals.

Under no circumstances will projection rights be granted to third parties without prior, express, written consent of the producers or their legal representatives.

Participants also authorise the Organising Committee to partially reproduce their films in the media with the aim of promoting the Festival.

### **Purposes of the data processing**

The management and administration of the 2019 BCN SPORTS FILM festival.

The publication of personal photographs on the website and social media, and, therefore, acceptance of these rules authorises the FBO (the Barcelona Olympic Foundation - *Fundació Barcelona Olímpica*) to take photographs and publish them, as mentioned above, on the website and social media.

### **Legitimation and retention period**

Participation in the competition will entail the express and unequivocal consent of the participant owning the data to their processing by the FBO in the terms and for the purposes stipulated above.

The legal basis for the processing of the data are these rules for the 2019 BCN SPORTS FILM festival.

The winning participants' personal data will be safeguarded for such time as they do not withdraw their consent.

### **Recipients**

Transfer of the personal data provided by data subjects to third parties is not envisaged beyond those provided for in these bases or provided that the interested party has given their consent.

However, if appropriate, they will be assigned to third parties only if the data subject grants his/her unequivocal consent or in cases of compliance with the execution of a contract, a legitimate interest, the public interest or legal obligations.

International data transfers are not envisaged.

### **Data categories**

The categories of data processed are as follows:

- Name and surnames
- ID card, Foreign Resident Identification Number or passport
- Postal or electronic address
- Phone number
- Images
- Signature

### **Security measures for the personal data**

In compliance with the current regulations, the FBO guarantees that it has taken all the technical and organisational measures necessary to maintain the required level of security, bearing in mind the nature of the personal data processed.

### **Rights of the data subject**

- a. Any person has the right to obtain confirmation of whether the FBO is processing his or her personal data.
- b. Data subjects have the right to access their personal data, as well as to request the rectification of any inaccurate data and, if appropriate, to request their deletion when, among other reasons, the data are no longer required for the purposes for which they were collected.
- c. Under certain circumstances, data subjects may request the restriction of the processing of their data, in which case the FBO will only retain them to file or defend itself against claims.
- d. Under certain circumstances, for reasons related to their particular situation, data subjects may object to the processing of their data. The FBO will cease to process the data unless there are compelling legitimate reasons to do so or to file or defend itself against claims.
- e. Data subjects may request the portability of their data from another data controller in automated form in the event of processing permitted by the General Data Protection Regulation.
- f. Upon the cancellation of the data they will only be retained in blocked status, in compliance with the legal obligations.

To sum up, data provided will be processed by the FBO in accordance with the purposes outlined in this document and, in this regard, you are informed that you may exercise your rights of access, rectification, deletion and restriction of their processing, oppose their processing and exercise your right to the portability of the data by writing to [protecciodades@fbolimpica.es](mailto:protecciodades@fbolimpica.es), without prejudice to your right to also file a complaint with the Spanish Data Protection Agency, the body which exercises supervisory authority in the matter, located at C/Jorge Juan, 6 - 28001 Madrid.

In any event, you may withdraw your consent at any time, without said withdrawal affecting the lawfulness of the processing based upon the consent granted prior to the withdrawal.

### **Consequences of non-acceptance of these bases**

In the event that participants do not accept the full content of these rules, they will not be allowed to take part in the competition.
